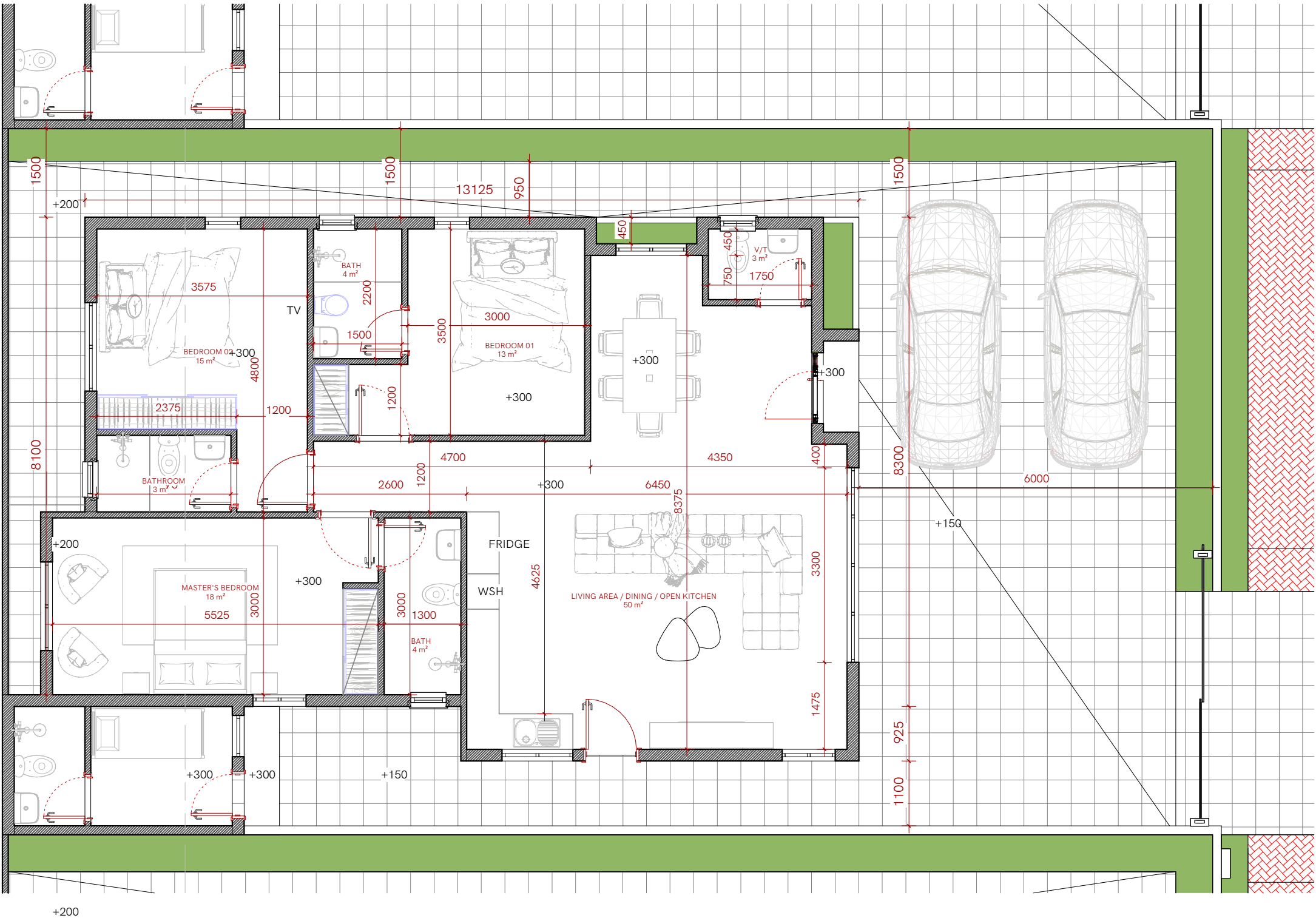




Floor Plan
